BENCHMARK FINANCIAL PLANNING FEES AND CHARGES

Ben may be paid by either Financial Planning Advice Fees and/or Commissions as described in the Financial Services Guide. The amount of the benefit and how it is calculated will be advised to you during your initial meeting.

Ben's hourly rate for Financial Services is \$330 incl. GST and you will be notified of the time involved prior to the commencement of any work if applicable.

Ben's fee for the preparation of a Statement of Advice ranges from \$1,500 to \$5,500 incl. GST depending on complexity. You will be notified of the cost involved prior to the commencement of any work if applicable.

Ben provides the option of ongoing reporting and advisory services. This fee is charged as an annual percentage of the value of your holding and is outlined in the table below. You will be notified of the cost involved prior to the commencement of any ongoing services.

Schedule of Fees for Ongoing Reporting and Advisory Services

For amounts less than \$100,000	1.10%
For amounts between \$100,000 to \$250,000	0.80%
For amounts between \$250,000 to \$1,000,000	0.50%
For amounts between \$1,000,000 to \$2,000,000	0.30%
For amounts above \$2,000,000	0.15%

NB. All figures in the above table include GST.

For example, the annual fee for ongoing reporting and advisory services for an investment of \$400,000, would be \$3,050 or 0.76% incl. GST.
